THE PORAM MANAGEMENT BOARD REPORT FOR THE YEAR ENDING DECEMBER 31, 2008

A. GENERAL

The 30th Annual General Meeting was held on May 14, 2008, at Sheraton Subang Hotel & Towers in Subang Jaya, Selangor.

On the market front, the Malaysian oil palm industry experienced tremendous volatility last year with prices rallying to a new historic high in early March 2008 but subsequently collapsing during the third quarter of the year.

On the management front, Yang Bhg Dato' Low Mong Hua was appointed as PORAM Acting Chairman on Dec 31, 2007 following the retirement of Mr Richard Cheang from PGEO Edible Oils Sdn. Bhd.

It is with profound sadness that we record here the passing away of Yang Bhg Dato' Low Mong Hua on April 13, 2008. Following Dato' Low's demise, Mr Yong Chin Fatt was appointed as Acting Chairman on April 24, 2008, for the remaining duration of the Management Board's term.

The year 2008 also saw other changes in the PORAM Management Board. Mr Gerry Leong Keng Kok of PGEO Edible Oils Sdn Bhd and Encik Ismail Hassan from Felda Vegetable Oil Products Sdn Bhd were nominated to serve on the Board from January 31, 2008. Mr Billy Tan of Kempas Edible Oil Sdn Bhd and Ms Linda Kee of Southern Edible Oil Industries (M) Sdn Bhd were nominated to serve on the Board from April 2008.

Among the activity highlights of 2008 were the PORAM annual events - the Annual Forum, the Malaysian Palm Oil Industry Golf Challenge and the PORAM Annual Dinner held on November 7-8, 2008. These three events were well supported by PORAM members, industry members and the agencies. The Annual Dinner was attended by YB Datuk Peter Chin Fah Kui, Minister of Plantation Industries and Commodities, while the Deputy Minister, YB Senator A. Kohilan Pillay, officiated at the Annual Forum.

Emphasis was also placed on training and development to continue to develop a pool of highly trained and competent human resources for the palm oil industry. This was reflected at the inaugural Joint MPOB-PORAM Introductory Course on Marketing and Trading of Palm Oil, which was successfully carried out from May 5-8, 2008.

B. MARKET REVIEW

The year was a mixed one for the palm oil refining industry of Malaysia. Despite the high prices of CPO during the first half of 2008, refining margin was good, something not seen for a long time. Ample supply of CPO and strong demand for Malaysian refined palm oil products created a favourable environment for the industry. The high export duty imposed by Indonesia created uncertainty and pushed demand towards Malaysia. However this favourable situation was short-lived as the high prices began to affect demand. In July and September, palm oil prices collapsed following a global unwinding of positions in commodities and equities triggered by the US financial crisis. The high palm oil stocks domestically also weighed heavily on the market. The credit crunch and fear of recession slowed global demand and affected exports of refined palm oil products. Deferment of shipments were common and worst of all, refiners were faced with default of their contracts.

In 2008, CPO production increased by 12.07% to 17.73 million metric tonnes from 15.82 million tonnes the previous year. The higher production was mainly attributed to a larger matured area and recovery in yields.

As at end 2008, there were 50 refineries in operation, with a total capacity of 19.198 million tonnes. Capacity utilization was recorded at a high 88.05%.

The total export of oil palm products, constituting palm oil, palm kernel oil, palm kernel cake, oleochemicals and finished products increased by 11.1% to 21.75 million tonnes in 2008 from the 19.57 million tonnes recorded in 2007. The total export earnings, however, increased by 44.3% or RM20.02 billion to RM65.19 billion, compared with RM45.16 billion in 2007.

Exports of palm oil were higher by 12.12% to 15.41 million tonnes from the level of 13.75 million tonnes recorded during 2007. China maintained its lead position as the largest export market for Malaysian palm oil for the seventh consecutive year, with a take-up of 3.79 million tonnes or 24.62% of Malaysia's total palm oil exports, followed by the European Union at 2.05 million tonnes (13.31%), Pakistan 1.25 million tonnes (8.16%), the United States 1.04 million tonnes (6.8%), India 0.97 million tonnes (6.3%) and Japan 0.54 million tonnes (3.5%).

Together, these top six importers accounted for 9.67 million tonnes or 62.7% of Malaysia's palm oil exports in 2008.

Exports of finished products increased significantly, by almost 91% to 670,612 tonnes from 351,183 tonnes in 2007. The major markets for finished palm oil products in 2008 were Iraq, which accounted for 20% of these exports, Kuwait (14%), Russia (8%) and UAE (7%). The major products exported were vegetable ghee/vanaspati, accounting for 302,298 tonnes or 45% of total finished product exports, followed by shortening at 192,735 tonnes or 29%.

The average CPO price rose marginally by 9.8% or RM247 to RM2,778 in 2008. The average export price for processed palm oil products also increased, with RBD Palm Oil going up by US\$34 or 4.47% to US\$806; RBD Palm Olein by US\$169 or 22.44% to US\$922 per tonne and RBD Palm Stearin by 5.59% to US\$775 per tonne.

C. LIAISON AND CONSULTATION WITH THE GOVERNMENT

I. Ministry of Plantation Industries and Commodities (KPPK)

Close consultations with the Government continued throughout the year under review. PORAM representatives participated in the Ministry's visits to EU and India (POTS). These visits were led by YB Datuk Peter Chin Fah Kui, Minister of Plantation Industries and Commodities (KPPK).

Several meetings were held to address the shortage of cooking oil in the domestic market, including the Cabinet Committee meeting on Competitiveness of Palm Oil (CCPO) chaired by YAB Prime Minister.

Dialogues were also held with YB KPPK Minister in November to discuss the then high palm oil stocks and prevailing market situations.

PORAM also took part in meetings convened by KPPK on:

- Development of Palm Oil Industrial Cluster (POIC) in Bintulu (Sarawak) and in Tanjung Langsat (Johor).
- National Coordinating Committee for Trilateral partnership on Market Access under the Malaysia/Indonesia/Netherlands Partnership.
- EC Biofuel Policy and Anti-palm oil campaign and the issue of sustainability.
- Cooking Oil Price Stabilisation Scheme (COSS)
- EC Registration, Evaluation, Authorisation of Chemicals (REACH) Regulation.
- Retreat: *Roadmap for the Malaysian Palm Oil Industry "Towards International Oil Palm Hub in 2020"*
- Strategic Package on Demand Intervention for Palm Oil
- KPPK Dialogue on Steps to Strengthen Palm Oil Prices

II. Malaysian Palm Oil Board (MPOB)

PORAM continued to support MPOB in its annual/biannual programmes such as the MPOB Palm Oil Familiarisation Programme, Advisory Committee Public Seminar, PORAM/MPOBTAS interaction, the Transfer of Technology Seminar and the MPOB Oil Palm Products Surveying Course, and National Seminar on Palm Oil Milling, Refining Technology, Quality and Environment.

The Association was also represented in various committees/working groups formed by MPOB to address related issues:

- National Codex Sub-Committee on Fats and Oils
- MPOB Sub-Working Group on Palm Oil (Malaysia-Indonesia Bilateral Cooperation)
- MPOB Working Group on Cooking Oil Price Stabilisation Scheme (COSS)
- Malaysia-Indonesia Bilateral Meeting on Sustainability Criteria for Biofuels in EU Directives
- MPOB Committee on Oils and Fats Standards
- MPOB Sub-Committee on Carotene
- National Coordinating Committee on Palm Oil (Trilateral Malaysia/Indonesia/Netherlands Partnership)
- MPOB National Committee on LCA Studies for Palm Oil Industry

A MPOB/PORAM committee was also established to organise the first-ever joint training programme for traders and marketers. The *Introductory Course on Trading and Marketing of Palm Oil* was held from May 5 to 8 last year at MPOB Bangi. PORAM was also invited to sit on the technical committee of the Global Economics & Marketing Palm Oil of PIPOC 2009.

III. Malaysian Palm Oil Council (MPOC)

PORAM continued to maintain regular dialogue and contacts with MPOC and its officials. MPOC also regularly provided PORAM with its informative publications and kept the Association abreast on current issues.

PORAM members also took part in various MPOC programmes, including the Palm Oil Trade Fair and Seminar (POTS) 2008 held in India, Palm Oil Trade Awareness Programme (POTAP) 2008, International Palm Oil Sustainability Conference 2008 in Kota Kinabalu, and the Malaysian Palm Oil Leadership Dinner (PILA) 2008, where the inaugural palm oil leadership award was presented to the former Minister of Primary Industries, YB Tun Dr Lim Keng Yaik.

MPOC joined hands with PORAM in hosting the Palm Oil Industry Annual Golf Game and also participated as a special sponsor in the PORAM Annual Forum.

PORAM played a role of “Supporting Partner” at MPOC’s Second International Palm Oil Trade Fair & Seminar, held in Kuala Lumpur.

IV. Ministry of International Trade and Industry (MITI)

During the period under review, PORAM was invited to attend several meetings convened by MITI to discuss:

- Operational certification procedure on the issuance of Certificate of Origin (COO) under the Malaysia-Pakistan Closer Economic Partnership Agreement (MPCEPA).
- Review of the Industrial Master Plan 3 – Manufacturing Sector Working Group (Oil Palm-based Industry)
- PORAM also sought the assistance of MITI to include Malaysia into the list of notified countries by India under its enforcement of arbitral awards legislation.

D. LIAISON WITH INTERNATIONAL AND LOCAL ORGANISATIONS

Close contact, consultation and meetings were also held with the following organisations:

I. INTERNATIONAL ORGANISATIONS

i. Federation of Oils, Seeds & Fats Associations Limited (FOSFA International)

FOSFA proposed that the transmission of contractual notices via email be allowed and that Contract 81 be amended accordingly to facilitate this provision. Correspondence was held on issues relating to security and reliability that needed to be addressed before PORAM's agreement to the proposal.

ii National Institute of Oilseed Products (NIOP)

Periodical circulars were received from the NIOP.

iii. ASEAN Vegetable Oils Club (AVOC)

PORAM representatives participated in the 13th AGM of AVOC on May 24 last year, held in Jakarta, Indonesia. At that meeting, AVOC recorded its acknowledgement and appreciation of PORAM for serving dutifully as the AVOC Secretariat since its inception in 1994.

iv Roundtable on Sustainable Palm Oil (RSPO)

PORAM representatives attended the Roundtable RT6 meeting held from November 17 to 21 in Bali, Indonesia, as well as in other meetings/public seminars convened by RSPO and MPOA throughout the year.

II. LOCAL ORGANISATIONS

i. Malayan Edible Oil Manufacturers' Association (MEOMA)

PORAM maintained close rapport with MEOMA in tackling issues related to palm oil. Both associations were also regularly represented in various committees and working groups, and have been discussing and addressing issues related to palm oil through meetings with relevant government ministries and agencies.

ii. Malaysian Palm Oil Association (MPOA)

We maintained a close rapport with MPOA, especially on common issues affecting the industry, such RSPO developments, trade contracts and the Malaysia-Indonesia Bilateral Cooperation.

iii. Bursa Malaysia

PORAM representatives participated in discussions with Bursa Malaysia on market practices for determining the good merchantable quality of palm oil.

iv. MOSTA

PORAM accepted MOSTA's invitation as partner of the Oils and Fats International Congress (OFIC), which was held from October 21 to 23. PORAM provided assistance in circulating promotion materials and supported the event with the participation of our members.

E. COMMITTEES

I. Commercial and Technical Committee

Chairman: Yang Bhg Dato' Er Kok Leong

The Committee met four times during the period under review. It established three Working Groups – Technical, Markets and Contracts, which meet on a need-to basis or conduct exchanges of views on issues via electronic correspondence.

These are some of the subjects deliberated by the Commercial and Technical Committee:

a. Domestic Cooking Oil Price Stabilisation Scheme (COSS)

Several meetings were held to deliberate the supply of subsidised cooking oil in the market, which have become a national issue following extensive media coverage. Discussions were also held to review the COSS scheme on the adjustment of threshold and ceiling price levels. The COSS scheme was implemented on June 1, 2007, and due to the escalation in palm oil prices, a review was warranted.

Last year, the government replaced the cooking oil cess with a “windfall levy”, effective July 1. The “windfall” is levied at 15% for Peninsular Malaysia and 7.5% in Sabah and Sarawak when the price of CPO/CPKO exceeds RM2,000 per tonne.

b. Proposed PORAM Palm Shortening Specifications for China Market

PORAM submitted proposed Palm Shortening specifications for the China market under the framework of the ASEAN-China FTA.

Under this agreement, there should be no import duty on imported palm shortening, while an 8% duty is chargeable under the mixed vegetable oil category. However, some difficulties were encountered by the Chinese authorities in differentiating

palm shortening from other palm oil products. The Ministry of Plantation Industries and Commodities has therefore requested PORAM to propose this specification.

c. Revised FOB Contracts

The revised FOB contracts and Arbitration Rules were enforced on January 1, 2008.

Contract No. 3 - PORAM Domestic Contract for Malaysian Processed Palm Oil in Bulk (For Delivery/Collection within Malaysia, including Singapore)

Contract No. 4 - PORAM FOB Contract for Processed Palm Oil Products in Drums

Contract No. 5 - PORAM CIF Contract for Processed Palm Oil Products in Drums

The amendments to the String Clause and Notice Clause in the PORAM/MEOMA FOB Contract were also discussed during the year under review, and revised versions took effect on January 1, 2009.

d. FOSFA 81 CIF Contract

FOSFA proposed that the transmission of contractual notices via email be allowed and that Contract 81 be amended accordingly to facilitate this provision. While PORAM acknowledged that transmission via email has been widely adopted by businesses, and supported FOSFA's proposal, PORAM recommended that issues relating to security and reliability need to be addressed before the FOSFA proposal can be accepted.

e. WTO/FTA/Market Developments

The WTO DOHA Round of Negotiations has not seen much progress during 2008.

The FTA negotiations involving ASEAN-India and India-Malaysia are continuing, while the ASEAN-EU FTA is in the preliminary stage of negotiations.

f. RSPO

PORAM participated in the Malaysia National Interpretation Working Group meeting convened by MPOA on March 18 to finalise the documents to establish the RSPO Principles and Criteria. The final document of the Working Group was sent to the RSPO Executive Board for endorsement.

The RSPO Trade and Traceability Working Group has also come up with a draft on “RSPO Supply Chain Certification Requirements”. Comments and views of members were collated for submission to RSPO, and a briefing session with industry stakeholders on the draft document was recommended.

g. EU REACH

The European Union Council on December 18, 2006, adopted the Registration, Evaluation and Authorisation of Chemicals Regulation (REACH). This regulation came into force on June 1, 2007, and covers all substances whether manufactured, imported, used as intermediates or put in the market, either on their own or in articles. This regulation requires manufacturers and importers of substances to be registered with the European Chemicals Agency (ECHA). In 2007, Malaysia appealed to the EU to have palm oil, palm kernel oil and some of the derivatives, including methyl esters, to be exempted from the regulation. Finally, the Commission Regulation (EC) in October 2008 had exempted vegetable oils and fats from the REACH Regulation.

II. PRICE SETTLEMENT COMMITTEE (PSC)

Chairman: Mr Chua Seow Yang

The Price Settlement Committee held a joint meeting with the Associate Members Committee on July 3, 2008. The meeting, chaired by the PORAM Chief Executive Officer, was to update members on recent developments pertaining to the palm oil industry, besides to foster closer ties between members of both committees.

The Committee continued to provide settlement prices requests from the trade as well as arbitrators for the purpose of settlement of disputes.

III. ASSOCIATE MEMBERS COMMITTEE (AMC)

Chairman: Mr Richard Goh

The Committee held a joint luncheon meeting with the Price Settlement Committee in Subang Jaya on July 3.

Among the matters discussed at the meeting were:

- FOB Contract – on the issue of origin of palm oil
- FOSFA Contract – on the recognition of the legality of email transmissions under Contract No. 81
- EU REACH
- FTA – Briefing of members on the status of the WTO and FTA negotiations
- MPOC POTS 2008
- PORAM Annual Events – Forum, Golf and Dinner

F. TRAINING AND EDUCATION

During the year under review, the following activities were organised:

i. Joint MPOB-PORAM Course May 5 to 8, 2008

The inaugural Joint MPOB-PORAM Introductory Course on Marketing and Trading of Palm Oil was successfully carried out from May 5 to 8,

2008. The main objective of this course is to continue develop a pool of highly trained human resources and ensure well-trained marketing and operational personnel at all levels of the palm oil industry.

The response to this 4-day course was overwhelming and attracted twice the number anticipated. The feedback obtained from participants indicated that such courses are very welcome, particularly for new entrants to the industry and as a refresher for those who are already in the industry.

ii. PORAM/MPOB Palm Oil Familiarisation Programme (POFP), August 13, 2008

The annual Joint PORAM/MPOB Interaction Session was held at the Prince Hotel & Residence, Kuala Lumpur, on August 13, 2008. This event attended by 70 people provided a networking platform between PORAM members and the foreign participants.

PORAM briefed the foreign participants on the roles and responsibilities of the Association, while PORAM members benefited from presentations on the prospects of palm oil in USA, Turkey, Uzbekistan, Egypt and Djibouti by representatives from these countries.

G. ARBITRATION & APPEAL (JAN - DEC 2008)

A total of 11 new arbitration cases and 3 appeal cases were filed with the PORAM Secretariat between January and December 2008.

The administrative fees stipulated under the PORAM Rules of Arbitration and Appeal was revised to RM5,000 and RM10,000 for PORAM members and non-members, respectively, while the basic fee for String Arbitration was revised to RM10,000 and RM20,000 for PORAM member and non-members, respectively. An additional fee of RM500 per contract is levied for each additional contract incorporated under the same arbitration proceeding. The new fees take effect on January 1, 2009.
